His book grew out of suggestions from the Publications Committee of the American Physiological Society, which has planned a series covering the development of ideas about a number of areas of physiology. This was prompted by the great success of *Circulation of the Blood: Men and Ideas*, edited by A. P. Fishman and D. W. Richards, which was originally published in 1964 and then reissued by the Society in 1982. Three companion books are being completed in conjunction with the centennial year of the American Physiological Society: this volume on endocrinology, one on the kidney, and one on membrane transport. It was our purpose not to provide a complete bibliography or a complete listing of all the progress made in a given area but to show the principal ideas and how they developed. Consequently, limitations were

placed on the number of references and on the length of each chapter. This book covers most of the areas of endocrinology; it is not completely comprehensive but discusses the main pathways of development and highlights the prominent investigators. We hope that the book as a whole will give an excellent picture of the evolution of this exciting area of physiology and the people involved in its growth. Most of the endocrine organs were discovered in antiquity by such early workers as Aristotle and Galen. The last endocrine gland to be discovered was the parathyroid in 1891 by Gley.

Fundamentals of Audiology for the Speech-Language Pathologist

This book illustrates the significance of biomedical engineering in modern healthcare systems. Biomedical engineering plays an important role in a range of areas, from diagnosis and analysis to treatment and recovery and has entered the public consciousness through the proliferation of implantable medical devices, such as pacemakers and artificial hips, as well as the more futuristic technologies such as stem cell engineering and 3-D printing of biological organs. Starting with an introduction to biomedical engineering, the book then discusses various tools and techniques for medical diagnostics and treatment and recent advances. It also provides comprehensive and integrated information on rehabilitation engineering, including the design of artificial body parts, and the underlying principles, and standards. It also presents a conceptual framework to clarify the relationship between ethical policies in medical practice and philosophical moral reasoning. Lastly, the book highlights a number of challenges associated with modern healthcare technologies.

Current Trends in Organic Synthesis

This book is a compilation of high-yield, at-a-glance summaries for various topics on which pathologists frequently need information in a quick reference format while at the microscope (or when cramming for the boards). The authors are early-career pathologists who have compiled this book from the perspective of pathologists-in-training. The focus is not organ-based histologic criteria, but rather everything else that goes into pathologic diagnoses but is difficult to keep committed to memory. The emphasis is on immunohistochemistry, special stains, grading systems, molecular markers, tumor syndromes, and helpful clinical references. The book has a unique format in that the information is presented primarily in tables and diagrams accompanied by minimal explanatory text. It is intended to serve as a 'peripheral brain' for pathology residents and also practicing pathologists, where frequently needed information is readily accessible and easy to navigate.

Our knowledge of reproductive medicine has expanded rapidly since the birth of Louise Brown, the first baby to be conceived by in vitro fertilization, which was performed by Professors Steptoe and Edwards in Bourn Hall, England, in 1978. Hardly a year goes by without the development of a new or the modification of an existing method of assisted reproduction. Within a relatively short period, in vitro fertilization has been introduced into the treatment of female infertility. Intracytoplasmic sperm injection has also created new opportunities for the treatment of male infertility. This manual takes stock of the techniques of assisted reproduction that are available today. Competent authors from various centers present, in a concise way, their tried-and-tested procedures, so that the latter can be readily implemented. Due to different legal regulations, the scope of assisted reproduction is much more limited in Germany than in many other countries. For example, whereas only three embryos may be conceived and transferred in Germany, such restrictions do not exist in several other European countries and the United States. Furthermore, heterologous fertilization, oocyte donation, and surrogate motherhood are banned in Germany. We are glad to have been able to recruit many international experts to present the various fields of assisted reproduction from their perspective. We hope this book will help to establish the different therapies and achieve a wide distribution.

Thus, there is a discontinuity in that the Gifu Conference organized by Prof. Kenji Takahashi was the fifth International Conference on Aspartic Proteinases. Officially, there has not been a sixth Conference and if there is confusion, it is the result of my desire to recognize the importance of the London meeting. Banffhosted 106 scientists from 14 different countries. There were 26 invited speakers among the 44 oral presentations of the 7 main sessions. In addition, there were 53 contributed poster presentations that spanned the whole range of interest in aspartic proteinases.
