A French Genocide: The Vendée provides a detailed narrative of the civil war in the Vendée region of western France, which lasted for much of the 1790s but was most intensely fought at the the height of the Reign of Terror, from March 1793 to early 1795. In this shocking and controversial book, Reyanld Secher argues that the massacres which resulted from the conflict between patriotic revolutionary forces and those of the counter-revolution were not the inevitable result of fierce battle, but rather were premeditated, committed in cold blood, massive and systematic, and undertaken with the conscious and proclaimed will to destroy a well-defined region, and to exterminate and entire people. Drawing upon previously unavailable sources, Secher argues that more than 14 percent of the population and 18 percent of the housing stock in the Vendée was destroyed in this catastrophic conflict. Secher's review of the social and political structure of the region presents a dramatically different image of the people on the Vendée than the stereotype common among historians favorable to the French Revolution. He demonstrates that they were not archaic and superstitious or even necessarily adverse to the forward-looking forces of the Revolution. Rather, the region turned against the Revolution because of a series of misguided policy choices that failed to satisfy the desire for reform and offended the religious sensibilities of the Vendéans. Using an array of primary sources, many from provincial archives, including personal accounts and statistical data, Secher convincingly argues for a demythologized view of the French Revolution. Contrary to most twentieth-century academic accounts of the Revolution, which have either ignored, apologized for, or explained away the Vendée, Secher demonstrates that the vicious nature of this civil war is a key element that forces us to reconsider the revolutionary regime. His work, available for the first time in English, provides a significant case study for readers interested in the relationships between religion, region, and political violence.

## **The Inscription in the 'Du Khang of Dgung 'phur Monastery, Spu Rang (Mnga' Ris)**

Empirical research is carried out in a cyclic way: approaching a research area bottom-up, data lead to interpretations and ideally to the abstraction of laws, on the basis of which a theory can be derived. Deductive research is based on a theory, on the basis of which hypotheses can be formulated and tested against the background of empirical data. Looking at the state-of-the-art in translation studies, either theories as well as models are designed or empirical data are collected and interpreted. However, the final step is still lacking: so far, empirical data has not lead to the formulation of theories or models, whereas existing theories and models have not yet been comprehensively tested with empirical methods. This publication addresses these issues from several perspectives: multi-method product- as well as process-based research may gain insights into translation as well as interpreting phenomena. These phenomena may include cognitive and organizational processes, procedures and strategies, competence and performance, translation properties and universals, etc. Empirical findings about the deeper structures of translation and interpreting will reduce the gap between translation and interpreting practice and model and theory building. Furthermore, the availability of more large-scale empirical testing

triggers the development of models and theories concerning translation and interpreting phenomena and behavior based on quantifiable, replicable and transparent data.

## **A French Genocide**

It seems as if the fundamentals of how we produce vowels and how they are acoustically represented have been clarified: we phonate and articulate. Using our vocal chords, we produce a vocal sound or noise which is then shaped into a specific vowel sound by the resonances of the pharyngeal, oral, and nasal cavities, that is, the vocal tract. Accordingly, the acoustic description of vowels relates to vowelspecific patterns of relative energy maxima in the sound spectra, known as patterns of formants. The intellectual and empirical reasoning presented in this treatise, however, gives rise to scepticism with respect to this understanding of the sound of the vowel. The reflections and materials presented provide reason to argue that, up to now, a comprehensible theory of the acoustics of the voice and of voiced speech sounds is lacking, and consequently, no satisfying understanding of vowels as an achievement and particular formal accomplishment of the voice exists. Thus, the question of the acoustics of the vowel - and with it the question of the acoustics of the voice itself - proves to be an unresolved fundamental problem.

In the past, foreign shocks arrived to national economies mainly through trade channels, and transmissions of such shocks took time to come into effect. However, after capital globalization, shocks spread to markets almost immediately. Despite the increasing macroeconomic dangers that the situation generated at emerging markets in the South, nobody at the North was ready to acknowledge the pro-cyclicality of the financial system and the inner weakness of “decontrolled” financial innovations because they were enjoying from the “great moderation.” Monetary policy was primarily centered on price stability objectives, without considering the mounting credit and asset price booms being generated by market liquidity and the problems generated by this glut. Mainstream economists, in turn, were not majorly attracted in integrating financial factors in their models. External pressures on emerging market economies (EMEs) were not eliminated after 2008, but even increased as international capital flows augmented in relevance thereafter. Initially economic authorities accurately responded to the challenge, but unconventional monetary policies in the US began to create important spillovers in EMEs. Furthermore, in contrast to a previous surge in liquidity, funds were now transmitted to EMEs throughout the bond market. The perspective of an increase in US interest rates by the FED is generating a reversal of expectations and a sudden flight to quality. Emerging countries’ currencies began to experience higher volatility levels, and depreciation movements against a newly strong US dollar are also increasingly observed. Consequently, there are increasing doubts that the “unexpected” favorable outcome observed in most EMEs at the aftermath of the Global Financial Crisis (GFC) would remain.
